The HPC Community Fund helps to mitigate the impact of the construction of the Hinkley Point C power station on local communities. Since it was launched, just four-and-a-half years ago, over £5 million has been committed to support a highly diverse range of charities, voluntary groups and organisations and I hope you'll enjoy reading a small selection of their stories here.

What they have in common is that they all improve the local quality of life, enhance community wellbeing and create new opportunities for people. Unsurprisingly, the Covid pandemic had a significant impact on these organisations, but it has been particularly pleasing to see them start to bounce back, not least through a record value of small grants to grassroots groups at the heart of local communities.

Somerset Community Foundation (SCF), an independent local charity (no 1094446), has overall responsibility for the delivery of this fund. I am very grateful to my colleagues and the Awards Panel members - which includes representatives from local councils and EDF, SCF trustees and independent members from local communities - for all their hard work and dedication, ensuring the fund continues to be run effectively and efficiently.




FUNDED PROJECT CASE STUDY Crimestoppers in the West Country

Crimestoppers is an independent charity that gives people the power to speak up to stop crime anonymously. In 2021 they were awarded a grant of £49,520 from the HPC Community Fund to support the 'What Would You Do?' drama-based workshops over a two-year period.



"The HPC Community Fund grant was awarded to support our 'What Would You Do?' programme, which includes working with 9-10 year-olds through drama-based workshops and performance across Somerset West and Taunton, and Sedgemoor. We know that many children, parents and carers are aware of crimes being committed – and by whom – in their communities, but they're reluctant to go to the police with the information. This project is an early intervention to grooming for gang crime, including county lines, online safety, healthy relationships, mob mentality and child exploitation. Through weekly sessions the children learn about these themes through participatory-led work. This culminates in stage and theatre performances and community films, where the key messages that are woven throughout the performances are then shared with their family members and audiences made up of the wider community."

Somerset Sight provides a unique and consistent point of support for anyone in the county experiencing sight loss. In 2020 they were awarded a grant of £85,000 from the HPC Community Fund to both deliver and expand their befriending and mobile advisory service in Sedgemoor, over a three-year period.

"We used our grant to grow our Volunteer Visiting Befriending Service in the Sedgemoor district of the county. Each of our volunteers visits one or two service users who they befriend, going on walks or taking them on trips to local garden centres or cafés. They assist with correspondence, check the fridge for out-ofdate items and generally offer bespoke support, helping in any way that's needed. Each volunteer is an absolute lifeline and provides contact with the outside world. They ensure service users can keep in touch with Somerset Sight and receive additional help when they need it. Service users learn about new initiatives, improvements in technology and free apps, activities, groups and social events in which they can join. Volunteers go the extra mile and many matches last for decades. We're so grateful for the funding from the HPC Community Fund, which enables us to provide this life changing service for people with sight loss living in the area."

# **Small Grants Programme**

Offering grants of up to £5,000 for smaller local organisations with an annual income of less than £100,000. The fund will also consider applications for up to £10,000, awarded over a three-year period, if the projects can demonstrate that they are addressing 'exceptional circumstances'.

In this financial year, 38 groups received funding through the Small Grants programme. Projects include supporting refugees, improving employment opportunities, enhancing the local environment and developing local amenities in addition to supporting groups with their core costs to help them better serve their communities.

Berrow and Brean Good Neighbours have community hubs and cafes in both villages, supporting and bringing together those who are new to the area and existing members of the two communities.

They received a grant for £1,000 in December 2021 from a special round of grants towards day-to-day running costs (also known as 'core costs') for small groups in the area who were particularly hard hit by the lockdowns.

"It was a difficult time for everyone during the first year or so of the pandemic. People became very isolated due to the lockdowns. Several of our members lost loved ones and were feeling extremely alone and vulnerable. The grant from the HPC Community Fund took the pressure off and allowed us to continue at a time when we were unable to fundraise as we would normally, at tabletop sales or selling teas, coffees and cake. We're here to support everyone, but especially families and individuals who have moved into the area - both locals and newcomers - who may be finding it difficult to become established in the community."



Shed activities include woodworking, joinery, metalwork, and crafts. The Minehead Shed, one of an estimated 1,800 Sheds globally, received an HPC Community Fund grant for £5,000 in 2021 to continue working on creating a permanent space in which isolated people can come together. Works include laying a new floor, and installing lighting, windows, toilet access, and equipment.

"Sheds are known for being popular with retirees who, once finishing work, often feel the loss of work friends, and an absence of purpose. However, following a number of open meetings, it was clear that many people, young and old, men and women, wished to get together to take part in Shed activities. We know that having a permanent base will help to tackle loneliness and isolation, and will bring many benefits to the community in and around Minehead. The percentage of males aged 65 and over in west Somerset is not far short of double that of the whole of the UK, and significantly greater than that for Somerset as a whole. Workers and their families could integrate into the community by The Minehead Shed, promoting a sense of wellbeing and avoiding any potential feelings of isolation. This integration, needless to say, will enrich the experience of the whole community."

St Mary's Church has recently grown as a community hub for Bridgwater and the surrounding area. They received a grant of £5,000 in 2022 for good quality, safe toddler equipment for their new baby and toddler group.

"We're passionate about community at St Mary's, and helping to create positive and supportive networks that enable people to flourish. In our work with families we became aware of the fact that many young families can feel isolated – and that accessible, welcoming places to meet others are not always easy to find. In response to this we decided to set up Babychinos. It's a welcoming environment for people to bring their babies and toddlers, meet others, and feel valued and supported. The equipment allows children to enjoy new experiences and interact, which aids their social development, while parents and carers have a positive space in which to flourish and find friendship. We're really excited that the grant has helped enable us to make a positive impact on the lives of local families."

# **Otterhampton Ring Fenced Fund**

Allocated funding of £500,000 within the Hinkley Point C site planning agreement.

A team comprising members of the Parish Council and community representatives identify projects and schemes to mitigate impacts being felt within the parish. This year, two grants have been awarded.

Otterhampton Parish Recreation Association (OPRA) are a registered charity who hold events such as firework displays, fetes, Easter egg hunts, walks and talks, and Christmas dinners in the parish. They received a grant of £11,180 in 2021 towards a new ride-on lawn mower for the upkeep of the village common.

"Alongside putting on various community activities and get-togethers across the year, OPRA took on responsibility for keeping the village common in Combwich mown. It's really popular and lots of people use it all year round. The common is a key outside space for our communities – it not only helps to keep local people from the parish connected with each other through the activities that are held there, it's also important in helping newcomers to integrate, including workers from the Hinkley Point C power station."

# **Strategic Grants Programme**

Community Cohesion was the first theme to be identified in 2017–18. This broad 'umbrella' term can be used to describe many aspects of community development and because of this, three focus areas were prioritised within the overarching theme. The first was strengthening Somerset communities, the second was supporting services (particularly for those community members in housing need) and the third was strengthening minority ethnic communities. Seven grants were awarded under this theme.

The second theme was Out of Hours Social Activities. This focus was identified to strengthen VCSE (voluntary, community and social enterprise) and public support in areas where workers and their families had moved and therefore social and leisure activities were increasing. Nine grants were awarded under this theme. Changes were agreed to many projects due to complications as a result of the coronavirus pandemic. Some projects were awarded continuation funding from the Strategic Grants Programme in order to mitigate the ongoing impacts felt in their communities.

Due to the coronavirus pandemic, changes were made which resulted in some projects continuing beyond the timescale originally agreed.



Diversity Voice, based in Bridgwater, champions intercultural integration through initiatives and events, providing support and services that help the inclusion of migrants and incoming workers, in and around Somerset. In 2018 the group were awarded a grant for £180,000 over three years from the HPC Community Fund, to work with those directly connected with Hinkley Point C and the wider community in Sedgemoor and the west of Somerset.

"The key aim was to facilitate integration of migrant workers and their families into the local community by providing advice and English language support to help people access services, by providing English lessons to help them become more independent, and by delivering events and training to bolster intercultural understanding. The grant funding from the HPC Community Fund has been invaluable, because it has meant that we have not only been able to deliver all of this, but have also been able to help the communities we serve to face the additional and disproportionate challenges they faced from the pandemic and the UK's exit from the European Union."

#### Notes on grants awarded in previous years:

In addition to the three awards listed above, the following organisations' funded projects continued into this year: Westfield United Reformed Church, Community Council for Somerset, Diversity Voice, Home-Start West Somerset, St George's Parish Centre Wembdon, and Citizens Advice West Somerset (formerly known as West Somerset Advice Bureau).



Street Pastors are trained volunteers from local churches. They are usually on patrol from 10pm up until 4am on a Saturday night to care for, listen to and help people who are out on the streets. A £30,000 grant meant they could increase the level of support provided on Saturday nights in the town centres of Bridgwater and Taunton.

"We now have Street Pastors on patrol virtually every Saturday night in Bridgwater (compared with one or two Saturdays per month before the funding) and have maintained every Saturday night in Taunton. Thanks to the HPC Community Fund grant, the Taunton and Bridgwater schemes have formally merged which has greatly strengthened the service we provide.

We work closely with organisations such as the police, night-time venues, and local homeless and mental health charities. In the last year alone, we estimate that around 3,000 potential weapons have been removed from the streets; 2,500 people have been directly supported; and 400 challenging situations have been resolved.

Street Pastors witness anti-social behaviour, violence, and the impact of drinking or drug taking on the streets, typically experiencing a dozen anti-social incidents each night in the town centres. The presence of the Street Pastors helps to resolve these situations. Most importantly, however, Street Pastors are hugely appreciated by the people they serve. People have come to respect that Street Pastors will deal with anyone and everyone without casting judgement, and they work through the night for the benefit of the community. So many people thank us for keeping them safe and for being a listening ear."
